

Is Astarta a bioenergy company?

Astarta put into operation one of the largest bioenergy complexes in Ukraine, with a production capacity of over 60m m³ of biogas per year. 2012 -- Astarta commissioned a heifer complex in the Poltava region with a designed capacity up to 5,000 young animals.

Is Astarta a good company?

The Company was highly rated for working conditions, preservation of jobs, students' involvement etc. Another business magazine "Delo" recognised ASTARTA among five best employers in Ukraine considering excellent reputation, social responsibility, personnel development.

Where is Astarta registered?

The Company is registered in the commercial register of the Chamber of Commerce and Industry for Amsterdam under number 34248891. ASTARTA's statutory seat is in Amsterdam, the Netherlands. The Company's registration address is Jan van Goyenkade 8, 1075 HP, Amsterdam, the Netherlands.

When did Astara become a brand in the Philippines?

Astara used to be known as Berg & Auto, which was first established in 1979. After several decades of experience, Astara formally entered the Philippine market with Peugeot under its wing in January 2022. The group then acquired the rights to distribute the GAC brand shortly thereafter.

What is Astarta doing now?

ASTARTA launched a pilot organic crop project by dedicating c. 2kha of farmland to growing organic produce with the first harvest of 3.5kt in 2020. The Company continues to modernise its agriculture machinery fleet in strategic partnership with John Deere.

How does Astarta manage sales?

ASTARTA provides for centralized sales of the Group's core products. This occurs via negotiations with consumers, drafting schedules of dispatching and sending them to subsidiaries. Control over sales is established in a way of control over execution of the dispatching schedules by the subsidiaries as well as cooperating with the consumers.
