

# Bosnia and Herzegovina conference energy storage

Is energy transition possible in Bosnia & Herzegovina?

Johann Sattler, Head of the EU Delegation and EU Special Representative in Bosnia and Herzegovina called on newly formed authorities to make full use of the available resources for energy transition, and underlined that change is achievable.

Who organizes the Energy Summit in Bosnia & Herzegovina?

The Summit is organized under the auspices of the Ministry of Foreign Trade and Economic Relations of Bosnia and Herzegovina, the State Regulatory Commission for Electricity, the Regulatory Commission for Energy of Republika Srpska, and the Regulatory Commission for Energy of the Federation of Bosnia and Herzegovina.

Herzegovina and the Ministry of Foreign Affairs of the Czech Republic, are organizing the Energy Summit 2023 in Bosnia and Herzegovina, from April 26 to 28, 2023, in Neum.

Which sector produces res energy in Bosnia and Herzegovina?

Production of RES energy in Bosnia and Herzegovina is dominated by the heating and cooling sector, for which an increase from the baseline 867.2 ktoe to 1085.2 ktoe in 2020 was planned. In addition, the share of electric energy sector in production of RES energy in the planned period increases from the baseline 444.2 ktoe to 760.6 ktoe in 2020.

How can the EU help Bosnia and Herzegovina achieve a green energy future?

The EU has made significant resources available for Bosnia and Herzegovina to speed up and scale up action towards a green energy future in Bosnia and Herzegovina, including through the Economic and Investment Plan for the Western Balkans, which makes 9 billion euro in grants available for the region.
