Pittsburg is the future home of Diablo Energy Storage, a 200-megawatt lithium-ion battery energy storage facility being constructed by LS Power, which, upon completion, will reliably and economically receive, store, and discharge electricity, including energy produced by renewable resources.

The five projects that are part of the proposal include Diablo Energy Storage, which has three separate 15-year agreements totalling 150MW and will be located in Contra Costa County. The Dynegy Marketing and Trade's Vistra Energy MOSS100 Energy Storage project, which is under contract to PG& E, has a ten-year agreement for 100MW.

This includes its 200MW Diablo Energy Storage facility located in Contra Costa County that was brought online in 2022, which happens to now be the center of a contract dispute with systems integrator Fluence - as reported in Energy-Storage.News at the end of last year.
