Oryx Energies has been present in The Gambia since 2017 when it acquired a majority stake in Atlas Energy Limited. In the last quarter of 2021, Oryx Energies ramped up its initial majority stake to full 100% ownership.

What are energy-related products (ERP) and energy-using products (EuP)?

Energy-related products (ErP) are products that use energy, or that do not use energy but have an indirect impact on energy consumption, such as water using devices, building insulation products, windows, etc. Compared to ErP, energy-using products (EuP) are products which are dependent on energy input (electricity etc.).

**Energy Related Products (ErP) Directive** ErP Directive (2009/125/EC) The ErP Directive establishes a framework for setting eco-design and minimum energy efficiency requirements for energy related products (ErP), imported into or sold in the European Union and replaces the earlier Eco-design Directive 2005/32/EC. As stated, this

What is ErP? ErP stands for Energy-Related Products, which is an energy regulation set by the European Union to improve the energy efficiency and performance of products. It is applied to products that use energy or have an impact on the consumption of energy. The regulation includes two directives, Ecodesign and Energy Labelling.

ErP stands for "Energy related Products". It is a new regulation, set by the European Union, that came into force in September 2015. The ErP Ecodesign of Energy related products directive. The production, distribution, use and end-of-life management of energy-related products (ErPs) is associated with important impacts on the environment, such as the consequences of energy and other materials/resources consumption, waste generation and release of hazardous substances.

As the name suggests, the ERP applies to all energy-related products that have a significant impact on the environment, i.e. those using electricity or renewable energy sources and products that can be made to be more energy efficient.
