What is the relationship between the EU and Nauru?

Here you will read about the EU's political,economic,trade and development cooperation with Nauru. The Republic of Nauru is a Micronesian Pacific island country. The relationship between the European Union and Nauru is governed by the EU-ACP Cotonou Partnership Agreement, which will soon be replaced by a successor Agreement.

What countries are included in ESS round 11?

The first edition of data and documentation for ESS Round 11 (2023/24) was released on Thursday 20 June 2024. Edition 1.0 includes data from the following countries: Austria, Croatia, Finland, Germany, Hungary, Ireland, Lithuania, Netherlands, Norway, Slovak Republic, Slovenia, Switzerland and United Kingdom.

Can European countries join ESS Eric?

European countries are welcometo join the ESS, even if they have previously not taken part or have been absent for some time. The inclusion of new Members enables ESS ERIC to increase the body of comparative data available and leads to lower costs of participation for all the nations involved.

How do I prepare a country for the ESS?

Support can be provided by the central ESS team to help prepare countries participating for the first time. Select a country to explore information about the ESS, available in their respective local languages. Countries have participated in at least one round of the ESS, providing data on attitudes, beliefs and behaviour.

Can Nauru accede to the EU-Pacific Economic Partnership Agreement?

As part of the ACP Pacific group, Nauru can accede to the EU-Pacific Economic Partnership Agreement (EPA), currently applied between the EU and Fiji, Papua New Guinea, Samoa and the Solomon Islands. The EPA would give Nauru duty-free, quota-free access for all its products to the EU market -- the world's largest single market.

How many countries participate in ESS?

Since 2002-2003, a total of 40 countries have participated in at least one round of data collection. In the most recent 2020-2022 ESS Round 10,32 countries are participating. In 2013, the ESS became an independent legal entity known as an ERIC and as of 2020 has 25 Member countries and one Observer country.
