Is Fiji Electricity Authority a public company?

Fiji Electricity Authority (FEA) was corporatised into Energy Fiji Limited (EFL) on 16 April 2018, a public company limited by shares, and was registered under the Companies Act. EFL has also been appointed as the successor entity of FEA.

#### Does Fiji still own EFL & Chugoku Electric?

The Government of Fiji will retain ownership of a 51% equity stake of EFLand aims to promote renewable energy usage up to 100% in the country by 2036. Chugoku Electric intends to accelerate renewable energy development such as hydro power and solar power in the country together with EFL.

Will Fiji achieve net-zero emissions by 2050?

In fact it is projected that Taveuni will be 100% renewable by the end of 2022 - effectively gaining zero carbon footprint status, followed by Ovalau in 2025. Thus, due to its efforts to transition to renewable and clean energy, EFL is helping Fiji realize its goal of net-zero emissions by 2050.

#### Why does Fiji have a uniform tariff rate?

It is also noteworthy that consumers are charged a uniform tariff rate that is regulated by the Fijian Competition and Consumer Commission (FCCC); the resultant affordability ensures Fijians of all socio-economic backgrounds are able to have equitable access to electricity services at subsidized rates.
