Why is universal energy access so popular in Morocco?

Universal energy access was the number one social policy of the Moroccan government in the 1990s and 2000s and gained very strong traction due to unconditional political support from the monarchy.

Is Morocco a success story in the energy sector?

Morocco has experienced a dramatic improvement in energy access rates over the past twenty years and has now become Africa's most celebrated success story in the sector.

How did the power sector reforms affect rural electrification in Morocco?

While the main outcome of the power sector reforms in Morocco was the privatization of national power production and distribution in the major cities, the reforms of the Moroccan power sector did not lead to the creation of a rural electrification agency.

Who is responsible for energy access in Morocco?

Morocco has followed a purely utility-driven approach, in which the national utility--the ONE, or Office National de l'Electricit  (National Electricity Company) --has responsibility over the entire energy access program in the kingdom.

Is Morocco a good example of Integrated Utility-led electrification?

Ten years after the conclusion of its universal energy access program, Morocco has now become one of the best examples of successful integrated utility-led electrification programs. In less than fifteen years, rural electrification rates in the kingdom skyrocketed from a bottom low of 18% in 1990 to nearly 100% presently.

Who pays for Morocco's national electrification plan?

Morocco's national electrification plan required customers to pay for about 25% of the overall investment and electrification costs, while the remaining 75% were paid by the public sector.

How does the Moroccan healthcare system operate? The healthcare system in Morocco consists of a public sector with universal care and a private sector. The state is responsible for the majority of health care expenditures in public hospitals, which account for 85% of all local health service. The remaining 15% are private hospitals financed mainly by payments from affiliates.

Morocco joined the WTO in 1995 and reports technical regulations that could affect trade with other member countries to the WTO. Morocco is a signatory to the Trade Facilitation Agreement and had a 91.2 percent implementation rate of TFA requirements as of 2024.
