[español]o [português]Grenada derives almost all of its energy from imported hydrocarbons. In 2020,non-renewables accounted for roughly 98% of installed capacity and electricity generation,with solar energy making up the difference.

Who is responsible for energy projects in Grenada?

The MOID( Ministry of Infrastructure Development, Public Utilities, Energy, Transport, and Implementation) is responsible for energy programs in Grenada. MOID handles the majority of permitting related to energy projects.

How do I get a generator permit in Grenada?

Electricity self generators must apply for a permit through the PURC( Public Utilities Regulatory Commission ), Grenada's regulatory authority for energy. GRENLEC ( Grenada Electricity Services) is the formerly privatized, now nationalized, electrical company of Grenada. Grenada does not have a national oil company.

Where do companies find oil & gas in Grenada?

Companies began to search for offshore oil and gas in Grenada's waters in 2017 following the passage of a Hydrocarbon Exploration Incentive Bill. The area of focus is where the maritime boundaries of Grenada and Trinidad and Tobago meet. During a 2018 exploration by Global Petroleum Group,indications of natural gas were found.
