Will Northland Power acquire 540mw of wind & solar in Spain?

Is Northland Power acquiring Helia Renovables in Spain?

Canadian power company Northland Power has signed a definitive agreement with Helia Renovables to acquire a 540MWwind and solar portfolio in Spain. The wind power market has grown at a CAGR of 14% between 2010 and 2021 to reach 830 GW by end of 2021.

What does Northland Power do?

Upon completion, the deal will position Northland as a top ten renewable power operator in Spain, creating a platform for growth in what is considered an attractive market for renewables. To fund the acquisition, Northland Power secured \$900m bought deal equity financing.

How many solar power plants are in Northland?

The targeted portfolio consists of 33plants in operation, of which 424 MW are onshore wind, 66 MW photovoltaic (PV), and 50 MW concentrated solar power (CSP). All assets operate under Spain's 2013 regulatory framework. Following the acquisition, Northland's total net installed capacity will rise to 2,806 MW.
