Will Orca drill in Q4 2022?

The Company has an active work program with plans for a 3D seismic acquisition in Q4 2022 to further prove up prospective resources for drilling. Orca has been successfully producing from Songo Songo since 2004 and is on track to deliver average production in 2022 of between 120 mmscfd and 130 mmscfd.
