Why is the power supply in the Solomon Islands so volatile?

Currently,most of the power in the Solomon Islands is dependent on diesel generated power which uses imported fuel. This volatile energy supply structure is susceptible to soaring fuel prices, and the people want it to be rectified as soon as possible.

Who is responsible for implementing a project in the Solomon Islands?

Solomon Powerwill be the implementing agency for the project and will have overall responsibility for project management. MMERE will oversee the implementation of the project on behalf of the Solomon Islands Government.

How much is the Solomon Islands infrastructure project worth?

The financing package for the project, worth over US\$200 million, through loans and grants from six institutions, marks the first large-scale infrastructure project for Solomon Islands to be developed as a public-private partnership (PPP).

Are natural resource rights applicable in the Solomon Islands?

To date, there have been no cases considering the applicability of these laws in the Solomon Islands. In addition to these broad principles, laws governing natural resource usage rights will also be relevant to the valuation of compensation.
