What is Xinyi Solar?

Xinyi Solar Holdings Limited is one of the world's leading photovoltaic glass manufacturers and specializes in research and development, manufacturing, sales, and after-sales services of photovoltaic glass.

Is Xinyi Solar a S&P Global Sustainability Yearbook 2024?

(Hong Kong, 17 July 2024) -- Xinyi Solar Holdings Limited (the "Company", together with its subsidiaries, "Xinyi Solar" or the "Group"; Stock Code: 00968), the world's largest solar glass manufacturer, is pleased to announce that the Group has made it into S&P Global's Sustainability Yearbook 2024 (China Edition) ("Yearbook").

What happened to Xinyi Solar?

Xinyi Energy was spun off and listed on the Hong Kong Stock Exchange. Xinyi Silicon was formed and Xinyi Solar was included in Hang Seng Index. The group had added 8 solar glass production lines (including cold repair), among which 3 production lines are in Wuhu Jiangbei, is the largest number in the industry.

How did Xinyi Solar perform in 2017?

In 2017, the company earned 9.527 billion HKD in revenue, an increase of 58.6% over the previous year, and a profit of 2.332 billion HKD, a 17.4% increase over the previous year. In June 2021 Xinyi Solar was added to the Hang Seng Index. In February 2022, it was added to the Hang Seng China Enterprises Index.

How did Xinyi Solar perform in 2023?

Xinyi Solar on Wednesday said net profit in 2023 rose 9.6% to HK\$4.19 billion (US\$535.2 million), supported by a jump in gross profit margin in the second half of the year on improving raw-material and energy costs. Deutsche Bank and Jefferies said the bottom line beat consensus estimates.

Where did Xinyi Glass invest in solar raw glass production line?

Xinyi Glass invested in the first solar raw glass production line. The first ultra-clear solar raw glass production line commenced production in Wuhu.
