The Adani Group is also involved in building a \$700 million terminal project at Sri Lanka''s largest port in Colombo. The cash-strapped South Asian island nation, which suffered from crippling power blackouts and fuel shortages during an economic crisis in 2022, has been trying to fast-track renewable energy projects to hedge against surges in imported fuel costs.
