Where is Terra based?

Formed in 2015, US-based Terra is engaged in gas production in the Piceance Basin, in Colorado. It holds 370,000 net acres that produce approximately 530 million cubic feet of gas per day (MMcf/d). Terra is focused on the acquisition and development of large producing oil and gas assets in North America.

Where are the Heard and McDonald Islands located?

The Heard and McDonald Islands are remote subantarctic volcanic features located in the Southern Ocean, halfway between Australia and South Africa. They are approximately 1700 km from the Antarctic continent and 4000 km southwest of mainland Australia (Australian Government 2016). Heard Island is 43 km long and 21 km wide.
