In 1994,it divested from its generation holdings on the larger island of Trinidad and now purchases energy from three Independent Power Producers (IPPs): the Power Generation Company of Trinidad and Tobago, which purchased the former T&TEC-operated plants and presently controls 1,386 megawatts (MW) of gas-fired capacity across

Trinidad and Tobago has abundant local fossil fuel resources, but is taking steps to prepare the societal, legal, regulatory, and economic foundations necessary to support renewable energy and energy efficiency technologies.

Does Trinidad & Tobago need energy subsidies?

Unlike many island nations, Trinidad and Tobago has significant oil and natural gas reserves and is a net exporter of these fuels. However, subsidies for domestic energy consumption have created a fiscal burden on the government that could be reduced through the expansion of alternative transportation fuels, energy efficiency, and renewable energy.

Is biomass a source of electricity in Trinidad & Tobago?

Traditional biomass - the burning of charcoal, crop waste, and other organic matter - is not included. This can be an important source in lower-income settings.
